## Handbook and Regulations for Undergraduate Awards 2016/17

#### **General updates**

The requirement for a student to have attempted the final assessment component in failed module between 30-39% in order to be awarded compensation has been removed.

#### Regulation 2.8 Re-entry to the university following academic failure

The regulation has been clarified to highlight that a student who has been expelled from the university may not apply at any point to return.

Repeating level 5 and 6 study (3.1.12; 3.1.14; 3.3.8; 3.4.7; 3.6.2; 3.7.3)

It has been clarified that a student would not normally be allowed to repeat level 5 or level 6.

#### **Regulation 3.1.19 Integrated Master's degree classification**

A generic regulation has been introduced for the classification of Integrated Master's degrees: Integrated master's degree classification will be based on the best 225 credits of the 240 at levels 5 and 6, singleweighted, and the best 105 credits of the 120 credits taken at level 7, triple-weighted.

## Taught Postgraduate Programmes University Regulations Twelfth edition – valid from July 2016 onwards

#### **General updates**

#### **Regulation 1.7 Intermediate Qualifications**

Regulation to be renamed Return of previous De Montfort University students to the university.

Clarification is provided on the return of study of students who have previously left the university for reasons other than academic failure. The regulation has additionally been clarified to highlight that a student who has been expelled from the university may not apply at any point to return.
