1. Introduction

Level 3 Programmes

2. Foundation Programme Nursing and Midwifery, B7B701

Nursing & Midwifery, No PSRB applicable

Passing a module/Compensation

- 2.1 All module components must be passed. The pass mark for each component is stipulated in the individual module specifications. No compensation is available.

3. International Year Zero in Pharmacy, C10005 and Year Zero Pharmacy, C10006

De Montfort University International College

Passing a module/Compensation

- 3.1 All module components must be passed. The pass mark for each component is stipulated in the individual module specifications. No compensation is available.

Reassessment of failure

- 3.2 Students on the programme are permitted reassessment opportunities to a maximum of 120 credits for Level 3. Each module may only be reassessed twice.

Undergraduate Programmes

4. Biomedical Science BSc (Hons), B90044

Allied Health Sciences, Institute of Biomedical Science (IBMS)

Compensation

- 4.1 It is a PSRB requirement that students must achieve a pass mark in all module components for all Level 6 modules. No compensation is available at Level 6.

Assessment

- 4.2 Due to PSRB requirements, BIOM3006 or BIOM 3701 (Research and Innovation) project must take the form of an independent project and can be laboratory-based, a systematic review including statistical analysis and evaluation, or a bioinformatics-type project. The project cannot be a literature review.

Awards of the University

- 4.3 Students who fail to meet the IBMS requirements specified in the programme specific regulations may be offered a non-IBMS-accredited exit award. Any exit award will follow the University's generic academic regulations. Exit awards are not recognised for registration purposes by the IBMS.

5. Children, Young People and Families Cert HE, L54011

Applied Social Sciences, No PSRB applicable

Passing a module/Compensation

- 5.1 All module components must be passed at 40%. No compensation is available.
- 5.2 Students must satisfy the attendance requirement of 70% for all academic modules.
- 5.3 As this is an apprenticeship, learners must complete a set number of off the job training (OJT) hours of which the Cert HE forms a part (OJT hours are calculated during onboarding and take into consideration contracted hours per week/annual leave and bank holidays across the length of the apprenticeship; therefore, OJT hours will vary for each apprentice).

Reassessment of failure

- 5.4 Students on the programme are permitted reassessment opportunities to a maximum of 90 credits, in any permutation or combination of module sizes.

6. Community Justice BA (Hons)/Grad Dip, L56048

Applied Social Sciences, No PSRB applicable

Passing a module/Compensation

- 6.1 All module components must be passed at 40%. No compensation is available.

Reassessment of failure

- 6.2 Up to 90 credits of reassessment opportunities are available. A student may have only one reassessment attempt at the 45-credit module and may utilise up to 45 credits of reassessment for the remaining modules, with a maximum of two reassessment attempts at any one module.

Undergraduate awards

- 6.3 This is a Level 6 programme and is therefore classified on the best 105 Level 6 credits. The Graduate Diploma does not receive a classification.

7. Community Justice Dip HE, L56050

Applied Social Sciences, No PSRB applicable

Passing a module/Compensation

- 7.1 All module components must be passed at 40%. No compensation is available.

Reassessment of failure

- 7.2 Students will be given one reassessment opportunity per module.

8. Community Justice BA (Hons)/Grad Dip, L56051

Applied Social Sciences, No PSRB applicable

Passing a module/Compensation

- 8.1 All module components must be passed at 40%. No compensation is available.

Reassessment of failure

- 8.2 Module credit sizes for the Level 6 programme are 1 x 20, 2 x 30, and 1 x 40. Students will be given one reassessment opportunity per module.

Undergraduate awards

- 8.3 The BA (Hons) is a Level 6 programme and is therefore classified on the best 105 Level 6 credits. The graduate diploma does not receive a classification.

9. Criminology with Psychology BA (Hons), L3C843

Applied Social Sciences, No PSRB applicable

Credits

- 9.1 The psychology credits for the Criminology with Psychology programme equal 75 credits in total. The 75 credits come from 30 credits at Level 4 and 15 credits at Level 5, and two 15 credit psychology modules at Level 6, which will complete the 75 credits.

10. Diagnostic Radiography BSc (Hons), B82141

Allied Health Sciences, Health & Care Professions Council (HCPC)

Passing a module/Compensation

- 10.1 No compensation of credits is available.

Reassessment of failure

- 10.2 At each level a student is permitted a maximum of 90 credits of reassessment in total across all attempts, with no more than one reassessment attempt in clinical practice modules and no more than two reassessment attempts in non-clinical practice modules.
- 10.3 At Level 4, a student cannot proceed to the clinical practice of DRAD1020 or commence DRAD1021 until they have passed the zero-weighted Passport to Practice (booklet) assessment in DRAD1020, that is completed before starting DRAD1020 but recorded as [art of the assessment for DRAD1020. If a student fails the Passport to Practice (booklet) assessment in DRAD1020, they will be permitted one reassessment for that component before the clinical practice of DRAD1020 commences. If a student fails the Passport to Practice (booklet) assessment following reassessment, they will be unable to proceed to the clinical practice of DRAD1020 or DRAD1021 and will be dismissed from the programme.
- 10.4 Clinical practice placements take place across two clinical practice modules at each level:
- Level 4 – DRAD1020 and DRAD1021
 - Level 5 – DRAD2020 and DRAD2021
 - Level 6 – DRAD3020 and DRAD3021
- 10.5 Clinical practice placements are assessed through clinical practice portfolios, which sit within DRAD1021, DRAD2021 and DRAD3021.

- 10.6 At levels 5 and 6 a student cannot begin the clinical practice modules until the clinical practice portfolio at the previous level has been passed.
- 10.7 If a student fails a clinical portfolio, the failure will be attributed to DRAD1021 (Level 4), DRAD2021 (Level 5) or DRAD3021 (Level 6). Reassessment of clinical portfolios may draw upon learning and practice from one or both of the clinical practice modules at each level, but the reassessment attempt and reassessment outcome will be attributed to DRAD1021 (Level 4), DRAD2021 (Level 5) or DRAD3021 (Level 6) only.
- 10.8 The standard regulations relating to reassessment with attendance do not apply to clinical practice modules. Where reassessment of clinical practice is required, a specific reassessment attendance plan will be specified.

Other Requirements – Admissions

- 10.9 Commencement and continuation on the programme are subject to enhanced DBS clearance and annual completion of a self-declaration. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration and re-registration respectively.
- 10.10 Failure to complete a DBS and annual self-declaration will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

Other requirements (September 2025 registration onwards)

- 10.11 In order to attend practice placements and to be eligible to continue the programme, students must be in sufficiently good mental and physical health to be able to practise without risk to themselves or others. All students must complete an annual self-declaration as per the HCPC guidance. Failure to do so will result in discontinuation from the programme.
- 10.12 Students must notify their Personal Tutor and academic assessor if they experience changes to their health status which might have an impact on their fitness to practise. This will then be discussed with the Programme Leaders, and supported by occupational health review as required.
- 10.13 Where there are serious concerns around professional conduct / values or fitness to practise, students will have a concerns form completed, and may be withdrawn from practice placement during investigation of the concerns.
- 10.14 Students who experience health issues that render them unable to practise safely and effectively may be unable to achieve the accredited degree of BSc (Hons) Diagnostic Radiography.

- 10.15 Students who take a leave of absence from their studies must complete a new occupational health questionnaire and must gain occupational health clearance before being allowed to resume their studies.
- 10.16 Students must complete a course of immunisation as advised by Occupational Health. Occupational Health will provide further advice on being vaccinated, and what vaccines are required. Without Occupational Health clearance and immunisation cover, students will not be able to attend clinical placements. Failure to undertake a course of immunisation as advised by Occupational Health may result in dismissal from the programme.

11. Education Studies BA (Hons), X30042

Applied Social Sciences, No PSRB applicable

Other requirements

- 11.1 Continuation on the programme is subject to enhanced DBS clearance. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration. Failure to complete a DBS will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

12. Education Studies with Languages BA (Hons), X39041

Applied Social Sciences, No PSRB applicable

Exit Awards

- 12.1 For a BA or BA (Hons) award in Education Studies with Languages, students must pass 30 credits of language modules at Level 5 and Level 6. If not, students are to be considered for a BA or BA (Hons) Education Studies award if they meet all other requirements.
- 12.2 To be awarded an UG Diploma in Education Studies with Languages, students must pass 30 credits of language modules at Level 5. If not, students are to be considered for an UG Diploma in Education Studies award if they meet all other requirements.
- 12.3 To be awarded a UG Certificate in Education Studies with Languages, students must pass 30 credits of language modules at Level 4. If not, students are to be considered for an UG Certificate in Education Studies award if they meet all other requirements.

Other requirements

- 12.4 Continuation on the programme is subject to enhanced DBS clearance. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration. Failure to complete a DBS will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

13. Education Studies with Mandarin BA (Hons), X39041

Applied Social Sciences, No PSRB applicable

Exit Awards

- 13.1 For a BA or BA (Hons) award in Education Studies with Mandarin, students must pass 30 credits of Mandarin modules at Level 5 and Level 6. If not, students are to be considered for a BA or BA (Hons) Education Studies award if they meet all other requirements.
- 13.2 To be awarded an UG Diploma in Education Studies with Mandarin, students must pass 30 credits of Mandarin modules at Level 5. If not, students are to be considered for an UG Diploma in Education Studies award if they meet all other requirements.
- 13.3 To be awarded a UG Certificate in Education Studies with Mandarin, students must pass 30 credits of Mandarin modules at Level 4. If not, students are to be considered for an UG Certificate in Education Studies award if they meet all other requirements.

Other requirements

- 13.4 Continuation on the programme is subject to enhanced DBS clearance. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration. Failure to complete a DBS will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

14. Education Studies with Psychology BA (Hons), X3C841

Applied Social Sciences, No PSRB applicable

Exit Awards

- 14.1 For a BA or BA (Hons) award in Education Studies with Psychology, students must pass 30 credits of psychology modules at Level 5 and Level 6. If not, students are to be considered for a BA or BA (Hons) Education Studies award if they meet all other requirements.

- 14.2 To be awarded an UG Diploma in Education Studies with Psychology, students must pass 30 credits of psychology modules at Level 5. If not, students are to be considered for an UG Diploma in Education Studies award if they meet all other requirements.
- 14.3 To be awarded an UG Certificate in Education Studies with psychology, students must pass 30 credits of psychology modules at Level 4. If not, students are to be considered for an UG Certificate in Education Studies award if they meet all other requirements.
- Other requirements**
- 14.4 Continuation on the programme is subject to enhanced DBS clearance. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration. Failure to complete a DBS will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

15. Education Studies with Qualified Teacher Status BA (Hons), X30043 (Apprenticeship)

Applied Social Sciences, No PSRB applicable

Other requirements

- 15.1 It is a PSRB requirement that apprentices must have GCSEs, **or equivalent**, in English, Maths and Science, at Grade C / 4 or above, before entering a Department for Education Teacher Training programme. Apprentices who do not yet have the required GCSE or **equivalent** grades in **maths and/or science** may register on the programme on the condition that they achieve the required grade(s) before commencing Level 6 of the programme. If an apprentice does not achieve the required grade(s) before commencing Level 6, deferral / leave of absence processes will be explored to ensure the apprentices has the required grade(s) before resuming their studies.
- 15.2 An Enhanced DBS certificate is a requirement for all adults working with children and vulnerable adults; therefore, students will be required to purchase an Enhanced DBS certificate before they can register on the programme and work in schools.

16. Forensic Science BSc (Hons), F41042

Pharmacy, Chartered Society of Forensic Sciences (CSFS)

Reassessment of failure

- 16.1 Reassessment opportunities at Levels 4, 5, and 6 will be taken at the end of the academic year.

17. Forensic Science MSci, F41052

Pharmacy, Chartered Society of Forensic Sciences (CSFS)

Reassessment of failure

- 17.1 Reassessment opportunities at Levels 4, 5, 6 and 7 will be taken at the end of the academic year.

18. Healthcare Science (Audiology) Top-up BSc (Hons), B61045

Allied Health Sciences, No PSRB applicable

Passing a module/ compensation

- 18.1 For the clinical practice modules all module components must be passed at 40%. All other modules must be passed at 40%. No compensation is available.

Reassessment of failure

- 18.2 Reassessment with attendance is not permitted.
- 18.3 Students will be allowed a maximum of 60 credits of reassessment at Level 6 and 15 credits at Level 5 in total over either the 2- or 3-year route. The zero-credit Level 4 module, HCSC1000, can be re-assessed once only.

19. Healthcare Science (Audiology) BSc (Hons), B61046

Allied Health Sciences, Health and Care Professions Council (HCPC), Academy for Healthcare Science (AHCS)

Passing a module/ compensation

- 19.1 There are parts of the programme that are compulsory which must be passed to proceed and graduate. All modules have a minimum 40% pass mark overall, apart from the observed structure clinical exam (OSCE). All OSCE elements have a minimum 60% pass mark. No compensation is available.

Reassessment with attendance

- 19.2 Reassessment with attendance is not permitted.

Reassessment of failure (Pre September 2024 registration)

- 19.3 A student may be reassessed in up to 60 credits of modules, per level of study.

Failure in clinical practice (September 2024 registration onwards)

- 19.4 Students who fail HCSC2114 or HCSC3111 will be eligible for one reassessment opportunity only.

Failure in clinical practice (Pre September 2024 registration)

- 19.5 Students who fail HCSC3601 may have only two reassessment opportunities for the practical exam/moderation. Students exceeding this will only be eligible to continue on a route for an academic award without eligibility for professional registration.

Undergraduate awards

- 19.6 Although the university regulation does allow the consideration of an Aegrotat award, it should be noted that if an individual were given such an award as part of the programme, they would not be eligible to apply for HCPC and AHCS registration. Similarly, if a student cannot achieve the BSc (Hons) Healthcare Science (Audiology) degree due to failure or withdrawal, any exit award will follow the University's generic academic regulations and will lead to an award in 'Hearing Science'. Exit and Aegrotat awards are not recognised for registration purposes by the HCPC or AHCS.

Other requirements

- 19.7 Continuation on the programme is subject to enhanced DBS clearance and annual completion of a self-declaration. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration and re-registration respectively.
- 19.8 Failure to complete a DBS and annual self-declaration will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.
- 19.9 In order to attend practice placements and to be eligible to continue the programme, students must be in sufficiently good mental and physical health to be able to practise without risk to themselves or others. All students must complete an annual self-declaration as per the HCPC guidance. Failure to do so will result in discontinuation from the programme.
- 19.10 Students must notify their Personal Tutor and academic assessor if they experience changes to their health status which might have an impact on their fitness to practise. This will then be discussed with the Programme Leaders, and supported by occupational health review as required.
- 19.11 Where there are serious concerns around professional conduct / values or fitness to practise, students will have a concerns form completed, and may be withdrawn from practice placement during investigation of the concerns.

- 19.12 Students who experience health issues that render them unable to practise safely and effectively may be unable to achieve the accredited degree of BSc (Hons) Healthcare Science (Audiology).
- 19.13 Students who take a leave of absence from their studies must complete a new occupational health questionnaire and must gain occupational health clearance before being allowed to resume their studies.
- 19.14 Students must complete a course of immunisation as advised by Occupational Health. Occupational Health will provide further advice on being vaccinated, and what vaccines may be required. Without Occupational Health clearance and immunisation cover, students will not be able to attend clinical placements. Failure to undertake a course of immunisation as advised by Occupational Health may result in dismissal from the programme.

20. Hearing Aid Audiology FDS, B61011 / B61012 (Apprenticeship)

Allied Health Sciences, Health and Care Professions Council (HCPC)

Passing a module/Compensation

- 20.1 All modules are must-pass modules and students must achieve a pass mark of 40% (unless otherwise stated). No compensation is available.

Reassessment of failure

- 20.2 Students will have a maximum of 90 credits of reassessment opportunities for the entire programme.

Undergraduate awards

- 20.3 Students must complete the Practical Proficiency Handbook and Record (PPHR) of their practical training through the two years in order to receive the award.

21. Low-Intensity Psychological Interventions Grad Cert, C84041

Applied Social Sciences, British Psychological Society (BPS)

Introduction to modules

- 21.1 The programme consists of 20-credit modules.

Passing a module/compensation

- 21.2 All module components must be passed at 40%, except the clinical assessments and case presentation which is 50% as per the module specifications. All zero-credit (pass/fail) components must be passed. No compensation is available.

Reassessment of failure

- 21.3 Students are only allowed one reassessment opportunity per module.
- 21.4 Failure of a module due to gross professional misconduct will result in immediate dismissal from the programme.
- 21.5 Students must maintain contractual services with the designated service provider for the duration of the programme. If they fail to do so they will be suspended pending investigation and may be discontinued from the programme.

Attendance

- 21.6 Each module has a 100% attendance requirement for taught content. The clinical practice element has an 80% attendance requirement. If a student falls below these requirements they must demonstrate that they have completed any missed work.

22. Midwifery BSc (Hons), B72051

Nursing & Midwifery, Nursing and Midwifery Council (NMC)

Passing a module/compensation

- 22.1 All module components must be passed at 40%. No compensation is available. Numeracy SafeMedicate© Exams sit in modules MIDW1006, MIDW2006 and MIDW3006. The exams have minimum pass thresholds of 80% (for MIDW1006), 90% (for MIDW2006) and 100% (for MIDW3006).

Reassessment of failure

- 22.2 A student will have a maximum of 90 credits of reassessment opportunities at each level of study.

Proceeding between undergraduate levels of study

- 22.3 Students must have passed 60 credits of modules to proceed to the next level of undergraduate study at the first assessment board and must have passed 90 credits of modules to continue to proceed through the next level of undergraduate study by the first reassessment board. If students achieve this, they may proceed with their cohort and take their reassessment of outstanding modules at the next available opportunity.

Awards of the university

- 22.4 Students must complete 120 credits at Level 6 to achieve a BSc (Hons) Midwifery with NMC registration as a midwife.
- 22.5 Exceptionally a student who has gained sufficient credit for the award may fail to achieve the award because of failing NMC professional conduct in practice or though the fitness to practise procedure.
- 22.6 Failure due to gross professional misconduct will result in immediate dismissal from the programme.
- 22.7 Two fails in professional conduct within one year or two consecutive fails of professional conduct will lead to discontinuation from the programme.

Undergraduate awards

- 22.8 If a student fails to achieve the Midwifery with NMC registration, any exit award will follow the University's generic academic regulations and will lead to an award in Health-Related Studies. Exit awards are not recognised for registration purposes by the NMC.

Other requirements - Admissions

- 22.9 Students must complete an occupational health questionnaire on registration and attend an occupational health assessment if asked to do so by the Programme Leadership team. Students who experience health issues that render them unable to practise safely and effectively may be unable to pursue the programme. Students must complete a course of immunisation as advised by Occupational Health. Without Occupational Health clearance and immunisation cover, students will not be able to attend clinical placements. Failure to undertake a course of immunisation as advised by Occupational Health may result in removal from the programme.
- 22.10 Where an applicant / student has been discontinued from a nursing or midwifery programme at DMU or another HEI following fitness to practise proceedings, they will not be permitted to apply or reapply to the programme for a minimum period of five years.

Other requirements

- 22.11 There is no recognition of prior learning (RPL) allowed within the Midwifery pre-registration programme.
- 22.12 The hours recorded on module specifications for theory and practice will be collectively combined across the duration of the students' programme to ensure that students are able to achieve the minimum credits required by the QAA for a BSc (Hons) award and the practice and theory hour requirements of the NMC.

- 22.13 It is a requirement of the programme that students attend clinical placement. Unauthorised non-attendance in placement will be investigated and may lead to discontinuation from the programme.
- 22.14 Students must complete and maintain a record of their achievement of the required clinical experiences (European Parliament and of the Council (2005) Directive 2005/36/EC of the European Parliament and of the Council. Annexe V, Point 5.5.1) in order to register with the NMC.
- 22.15 Continuation on the programme is subject to enhanced DBS clearance and annual completion of a self-declaration. It is important that the DBS application and self-declaration are completed by the end of teaching week 4 after registration and re-registration respectively.
- 22.16 Failure to complete a DBS and annual self-declaration will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

Passing a module/compensation (September 2022 registration onwards)

- 23.2 All module components must be passed at 40%. In some instances, the pass mark can be higher than 40%. All zero-credit (pass/fail) components must be passed. No compensation is available.

- 23.3 Students will have two reassessment opportunities for the weighted components of practice modules and the numeracy examination in NURX/Y2100.
- 23.4 All practice components for each Part must be achieved by the end of the Part. Should a student fail a zero-weighted component of the Practice Experience 1, 2 or 3 modules, they will be able to submit that component for one resubmission attempt (therefore allowing two attempts in total). Reassessment must be completed by the midpoint of the next placement block; this will be considered a summative submission date. If a student fails a zero-weighted component on their resubmission attempt, they will be

- discontinued from the programme and may be offered a non-NMC accredited exit award.
- 23.5 Failure of the zero-weighted practice components of the Practice Experience 1, 2 and 3 module assessments will not result in capping of the weighted assessment for the modules.
- 23.6 Students must achieve all practice components at the final summative point in Part 3, to complete the programme. If not achieved, a formal placement extension request must be made to the Programme Leader and the Director of Practice, to allow reassessment of all outstanding components. An extension period of no less than four weeks is required for reassessment of any outstanding components.
- Reassessment of failure (September 2020 – September 2021 registration)**
- 23.7 Professional Experience 1, 2 and 3 are zero-credit modules which embed the practice requirements for nursing. Each zero-credit module can be reassessed on one occasion (therefore allowing two attempts in total).
- 23.8 All practice components for each Part must be achieved by the end of the Part. If the module is failed at the first assessment, re-assessment must be completed by the midpoint of the next placement block; this will be considered as a submission date.
- 23.9 Students must have passed all practice components by the final summative point in Part 3 to complete the programme. If not achieved, a formal placement extension request must be made to the Programme Leader and Director of Practice to allow re-assessment of all outstanding components. An extension period of no less than four weeks is required for reassessment of any outstanding components.
- Reassessment of failure (Pre September 2020 registration)**
- 23.10 Professional responsibility 1 and 2 are zero-credit modules which embed the practice requirements for nursing. Each zero-credit module can be reassessed on two occasions. If the module is failed at the first reassessment the student will be back-grouped to a different cohort to allow the second and final attempt at the module. No reassessment is available on the back-grouped attempt.
- Proceeding between undergraduate levels of study**
- 23.11 Students must have passed 60 credits of modules to proceed to the next level of undergraduate study at the first assessment board and must have passed 90 credits of modules to continue to proceed through the next level of undergraduate study by the first reassessment board. Students cannot proceed into Level 6 if they have Level 4 components to retrieve.

Undergraduate awards (September 2022 registration onwards)

- Reassessment of failure**
- 26.2 A student will have a maximum of 90 credits of reassessment opportunities at each level of study.

Proceeding between undergraduate levels of study

- 26.3 Students must have passed 60 credits of modules to proceed to the next level of undergraduate study at the first assessment board and must have passed 90 credits of modules to continue to proceed through the next level of undergraduate study by the first reassessment board. If students achieve this, they may proceed with their cohort and take their reassessment of outstanding modules at the next available opportunity.

27. Paramedic Practice BSc (Hons), B95092 (Apprenticeship)

Allied Health Sciences, Health and Care Professions Council (HCPC)

Assessment

- 27.1 All module components and modules are must-pass. No compensation is available.
- 27.2 If a student is advised to terminate practice placement before the final assessment for reasons related to the Fitness to Practise Policy, then the Fitness to Practise Process will be initiated.

Reassessment of failure

- 27.3 Students will have one reassessment attempt per module.
- 27.4 Should a student fail the zero-credit, Pass/ Fail practice placement module, they will be back-grouped to facilitate the permitted one reassessment attempt. If a student fails a practice module at any level, they are not permitted to be reassessed with attendance.

Exit awards

- 27.5 Students who are not awarded BSc (Hons) may be eligible for an exit award. The title of the exit awards is "Principles of Pre-Hospital Practice".

Maximum Period of Registration

- 27.6 Due to the rapidly changing scope of clinical practice and nature of the changing role of the paramedic, the maximum registration period for this award is five years (full-time). This will ensure that graduating students are fit to practise in a dynamic and changing environment and that they are safe and competent as independent practitioners at the point of HCPC registration.

Attendance

- 27.7 Apprenticeship attendance is 100% unless absence is authorised

End point assessment

- 27.8 As the programme is integrated and aligned students will meet the gateway criteria as part of the integrated assessment plan. The External Examiner will act as the External

Quality Assessor. Given that the award board is the End Point Assessment (EPA), their role will be focused on assessment boards arrangements and internal quality assurance.

28. Paramedic Science BSc (Hons), B95042

Allied Health Sciences, Health and Care Professions Council (HCPC)

Assessment

- 28.1 All module components and modules are must-pass. No compensation is available.
- 28.2 If a student is advised to terminate practice placement before the final assessment for reasons related to the Fitness to Practise Policy, then the Fitness to Practise Process will be initiated.

Reassessment of failure

- 28.3 Students will have one reassessment attempt per module.
- 28.4 Should a student fail the zero-credit, Pass/ Fail practice placement module, they will be back-grouped to facilitate the permitted one reassessment attempt.

Exit awards

- 28.5 Students who are not awarded BSc (Hons) Paramedic Science may be eligible for an exit award. The title of the exit award is "Principles of Pre-Hospital Practice."

Attendance

- 28.6 Students must attend all scheduled placement shifts unless they have reasonable justification, i.e. sickness or authorised absence.

Other requirements

- 28.7 Students must complete a course of immunisation as advised by Occupational Health. Occupational Health will provide further advice on being vaccinated, and what vaccines may be required. Without Occupational Health clearance and immunisation cover, students will not be able to attend clinical placements. Failure to undertake a course of immunisation as advised by Occupational Health may result in dismissal from the programme.

Maximum periods of registration

- 28.8 Due to the rapidly changing scope of clinical practice and nature of the changing role of the paramedic, the maximum registration period for this award is five years (full-time). This will ensure that graduating students are fit to practise in a dynamic and changing environment and that they are safe and competent as independent practitioners at the point of HCPC registration.

29. Pharmacy, Pharmacy with Preparatory Year, MPharm B23045, B23046, B23146

Pharmacy, General Pharmaceutical Council (GPhC)

Passing a module/compensation

- 29.1 All modules are must-pass. This includes PHAR0101, PHAR1801, PHAR2801, PHAR3801, PHAR4801 which are zero-credit (pass/fail) modules. No compensation is available.
- 29.2 All components within all modules are must-pass. This includes the pass/fail components within the zero-credit modules. The pass mark required for each component is stipulated in the individual module specifications.

Reassessment of failure

- 29.3 At each level a student is permitted a maximum of 120 credits of reassessment in total across all attempts, with no more than two reassessment attempts in any module.
- 29.4 Each zero-credit module has only one reassessment opportunity. Once passed, a zero-credit module cannot be reassessed.

Proceeding between undergraduate levels of study

- 29.5 Students must pass all modules before proceeding to the next level.

Maximum period of registration

- 29.6 The normal expected duration of the Pharmacy programme is four years and the mode of study is full-time only. The maximum period of registration for the programme is normally six years and the maximum period allowed for studying at any one level is normally two years.
- 29.7 The normal expected duration of the Pharmacy with Preparatory Year programme is five years and the mode of study is full-time only. The maximum period of registration for the programme is normally seven years and the maximum period allowed for studying at any one level is normally two years.

Exit awards

- 29.8 If a student fails to achieve the MPharm qualification, any exit award will follow the University's generic academic regulations and will lead to an award in Pharmaceutical Studies. Exit awards are not recognised for registration purposes by the GPhC.

Other requirements

- 29.9 Continuation on the Pharmacy and Pharmacy with Preparatory Year programmes is subject to enhanced DBS clearance at level 4 and annual completion of a self-declaration. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration and re-registration respectively.

- 29.10 Failure to complete a DBS and annual self-declaration will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

30. Pharmacy MSci, B23060, Pharmaceutical Technical University (Uzbekistan)

Pharmacy, No PSRB applicable

Passing a module/compensation

- 30.1 All modules are must-pass. No compensation is available.
- 30.2 All components within all modules are must-pass. This includes the pass/fail components within the zero-credit modules. The pass mark required for each component is stipulated in the individual module specifications.

Reassessment of failure

- 30.3 A student will have a maximum of 120 credits of reassessment opportunities at each level of study. Reassessment will take place at the end of the academic year. Students are entitled to a maximum of two reassessment opportunities for credit bearing academic modules. Students are entitled to one reassessment only for zero-credit modules. Failure of multiple module components will be counted as a single module reassessment. The overall module mark will be capped at the pass threshold.

Proceeding between undergraduate levels of study

- 30.4 Students must pass all modules before proceeding to the next level.

Exit awards

- 30.5 If a student fails to achieve the MSci Pharmacy qualification, any exit award will follow the University's generic academic regulations and will lead to an award in Pharmaceutical Studies.

31. Practice Nursing BSc/Grad Cert, B70098

Nursing & Midwifery, Nursing and Midwifery Council (NMC)

Introduction to programmes and modules

- 31.1 The programme consists of one 60-credit module.

Passing a module/compensation

- 31.2 All module components must be passed at 40%. All zero-weighted (pass/fail) components must be passed. No compensation is available.

Reassessment of failure

- 31.3 A maximum of 60 credits of reassessment are permitted. Each module component may only be reassessed once.

32. Professional Clinical Practice BSc (Hons)/BSc/Grad Cert/Grad Dip, B70241

Nursing & Midwifery, Nursing and Midwifery Council (NMC), Health and Care Professions Council (HCPC) accreditation applies to PRES3005 and PRES3006

Passing a module/compensation

- 32.1 All module components must be passed at 40%. All zero-credit (pass/fail) components must be passed. No compensation is available.
- 32.2 Students undertaking PRES3005 Applied Prescribing Module will have one resit opportunity for each assessment component (the Reflection and the Portfolio).
- 32.3 Students undertaking PRES3006 Pharmacology for Prescribers will have one re-sit opportunity for each assessment component.
- 32.4 Students undertaking PRES3006 Pharmacology for Prescribers will have one re-sit opportunity for the numeracy within the module. If the student fails both these attempts, they will be allowed one final re-sit opportunity after the exam board.
- 32.5 The pass mark for the pharmacology exam in PRES3006 Pharmacology for Prescribers is 80%.
- 32.6 The pass mark for the numeracy exam in PRES3006 Pharmacology for Prescribers is 100%.
- 32.7 PRES3005 and PRES3006 must be taken together and must both be passed.

Maximum period of registration

- 32.8 The maximum periods of registration will normally be two years on the BSc/Grad Cert and three years on the BSc (Hons)/Grad Dip.

Recognition of Prior Learning (RPL)

- 32.9 For non-honours (BSc) students, 15 credits of RPL are available at Level 6. For honours (BSc Hons) students, 45 credits of RPL are available at Level 6.

Classification of awards BSc (Hons)

- 32.10 This is a Level 6 programme and is therefore classified on the best 105 Level 6 credits.
- 32.11 Where a student has studied and passed more than 120 credits, degree classification will be based on an average of the total number of credits, excluding the 30 credits with the lowest mark(s). Where a student has studied and passed less than 120 Level 6 credits (due to RPL), classification will be based upon the average of the marks for all modules studied.

33. Degree in Professional Policing BA (Hons), L43582

Applied Social Sciences, College of Policing (CoP)

Passing a module/compensation

- 33.1 All core module components must be passed at 40%. No compensation is available.

Reassessment of failure

- 33.2 A student will have a maximum of 90 credits of reassessment opportunities at each level of study.

Proceeding between undergraduate levels of study

- 33.3 Students must pass all modules before proceeding to the next level.

34. Professional Policing Practice BA (Hons), L43591 (Apprenticeship)

Applied Social Sciences, College of Policing (CoP)

Passing a module/compensation

- 34.1 All module components must be passed at 40%. No compensation is available.
- 34.2 CRIM1202 Legislation, Policy & Practice at Level 4, consists of 2 assessments. Assessment 1 is a multiple choice exam with a pass mark of 60%. Assessment 2 is a 20-minute presentation reflecting on role plays with a pass mark of 50%.
- 34.3 The CoP require higher thresholds on exams and reflective assessments at Level 4.
- 34.4 To proceed through the 'Gateway' to End Point Assessment (EPA), students must:
- Accrue 300 academic credits
 - Achieve 'Operational Competence' by way of successfully completing their 'Operational Competency Portfolio' (OCP) by the end of year 2 which sits within CRIM2204

- Have achieved at least a Level 2 award in English and Maths
- Demonstrate to both Leicestershire Police and DMU academics that the requisite Knowledge, Skills and Behaviours (KSB's) detailed in the 'Apprenticeship Standard' have been achieved in preparation for the EPA.

34.5 Before undertaking the final End Point Assessment, students must register and appropriately record at least 20% Off-The-Job learning hours (OTJ).

34.6 The integrated End Point Assessment (EPA) has a pass mark of 40% as dictated by the Institute of Apprenticeships and the College of Policing.

Reassessment of failure

34.7 Students on the programme will be permitted reassessment opportunities to a maximum of 90 credits at each academic level. Students have a maximum of three reassessment attempts at any one module.

Proceeding between undergraduate levels of study

34.8 Students need to pass all Level 4 modules and achieve Independent Patrol Status in order to proceed to Level 5.

34.9 Students need to pass all Level 5 modules, including the Occupational Competency Portfolio situated within CRIM2204 in order to proceed to Level 6.

35. Psychology with Criminology BSc (Hons), C80046

Applied Social Sciences, British Psychological Society (BPS)

Credits

35.1 Joint honours programmes with Psychology as the major subject will comprise of 285 credits of Psychology modules and 75 credits of second subject modules. Specifically, students will complete 90 credits of Psychology modules and 30 credits of second subject modules at Level 4, 105 credits of Psychology and 15 credits of the second subject at Level 5, and 90 credits of Psychology and 30 credits of the second subject at Level 6.

36. Psychology with Education Studies BSc (Hons), C80045

Applied Social Sciences, British Psychological Society (BPS)

Credits

- 36.1 Joint honours programmes with Psychology as the major subject will comprise of 285 credits of Psychology modules and 75 credits of second subject modules. Specifically, students will complete 90 credits of Psychology modules and 30 credits of second subject modules at Level 4, 105 credits of Psychology and 15 credits of the second subject at Level 5, and 90 credits of Psychology and 30 credits of the second subject at Level 6.

37. Psychology with Health and Wellbeing in Society BSc (Hons), C80048

Applied Social Sciences, British Psychological Society (BPS)

Credits

- 37.1 Joint honours programmes with Psychology as the major subject will comprise of 285 credits of Psychology modules and 75 credits of second subject modules. Specifically, students will complete 90 credits of Psychology modules and 30 credits of second subject modules at Level 4, 105 credits of Psychology and 15 credits of the second subject at Level 5, and 90 credits of Psychology and 30 credits of the second subject at Level 6.

38. Psychology with Sports Management BSc (Hons), C80047

Applied Social Sciences, British Psychological Society (BPS)

Credits

- 38.1 Joint honours programmes with Psychology as the major subject will comprise of 285 credits of Psychology modules and 75 credits of second subject modules. Specifically, students will complete 90 credits of Psychology modules and 30 credits of second subject modules at Level 4, 105 credits of Psychology and 15 credits of the second subject at Level 5, and 90 credits of Psychology and 30 credits of the second subject at Level 6.

39. Social Work BA (Hons), L50044

Applied Social Sciences, Social Work England (SWE)

Passing a module/compensation

- 39.1 All module components must be passed at 40%. No compensation is available. The programme has a number of credit-bearing pass/fail modules (30 credits at Level 5; 45 credits at Level 6).

Proceeding between undergraduate levels of study

- 39.2 The standard regulations for reassessment with attendance do not apply. Students must satisfy the attendance requirement of 70% for all academic modules. Any fails for attendance must be retrieved before a student is allowed to proceed.
- 39.3 Students must achieve 100% attendance for the required number of placement days at each level.
- 39.4 Students cannot proceed to the next level of practice placement without having achieved the credits for the previous practice placement.
- 39.5 Normally students may commence the academic modules at Level 5 carrying no more than one fail in an academic module at Level 4. The academic fail must be redeemed by the end of semester one in Level 5. No work will be ratified at the higher level until the previous failure has been redeemed. Students will not be able to proceed to placement until all Level 4 modules have been passed, including attendance requirements.
- 39.6 Normally students may commence the academic modules at Level 6 carrying no more than one fail in an academic module at Level 5. The academic fail must be redeemed by the end of semester one in Level 6. No work will be ratified at the higher level until the previous failure has been redeemed.
- 39.7 Where a student fails the attendance requirement for all modules of the level they are studying, they will not be permitted to continue on the programme and will be dismissed in accordance with DMU regulations.

Awards of the university

- 39.8 Classification will be based upon the best 150 from 165 Level 5 and 6 credits, triple-weighted towards Level 6.

Other requirements

- 39.9 Continuation on the programme is subject to enhanced DBS clearance and annual completion of a self-declaration. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration and re-registration respectively.

- 39.10 Failure to complete a DBS and annual self-declaration will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

40. Speech and Language Therapy BSc (Hons), B60051 (for students registering from September 2024 onwards)

Allied Health Sciences, Health and Care Professions Council (HCPC), The Royal College of Speech and Language Therapists

Passing a module/compensation

- 40.1 All modules are must-pass modules and students must achieve a minimum pass mark of 40%. No compensation is available.

Failure in clinical practice

- 40.2 Students who fail SALT2404 (Developing Clinical and Professional Practice 2) due to failure in their Practice Educator Assessment (but not the presentation and written assignment) may have only one reassessment opportunity for the clinical placement of that module. Students exceeding this will only be eligible to continue on a route for an academic award without eligibility for state registration.
- 40.3 Students who fail SALT3402 (Establishing Clinical and Professional Practice) due to failure in the Practice Educator Assessment (but not the Personal and Professional Development Plan and Clinical and Professional Portfolio) may have only one reassessment opportunity for the clinical placement component of that module.
- 40.4 Students who fail SALT3402 (Establishing Clinical and Professional Practice) due to failure in the Practice Educator Assessment are not permitted to attempt the placement in SALT3404 (Towards Autonomy in Clinical and Professional Practice) until they have successfully retrieved the failed placement in SALT3402.
- 40.5 Students who fail SALT3404 (Towards Autonomy in Clinical and Professional Practice) due to failure in the Practice Educator Assessment (but not the Professional Case Study Assignment and Professional exit Viva) may have only one reassessment opportunity for the clinical placement module. Students exceeding this will only be eligible to continue on a route for an academic award without eligibility for state registration.

Proceeding between undergraduate levels of study for full-time students

- 40.6 Students must pass 120 credits before proceeding to the next level.

Proceeding between undergraduate levels of study for part-time students

- 40.7 Part time students must pass 60 credits per academic year. A student must have passed 120 credits before proceeding to the next academic level of study.

Fitness to practise

- 40.8 In order to attend practice placements and to be eligible to apply for professional registration students must be in sufficiently good mental and physical health to be able to practise without risk to themselves or others. Students must notify their Personal Tutor and the Clinical Placement Lead if they experience changes to their health status which might have an impact on their fitness to practise. This will then be discussed with the Programme Leader and supported by occupational health review as required. Students must attend for occupational health assessment if asked to do so by the programme leader or deputy.
- 40.9 Where there are serious concerns around fitness to practise, students may be withdrawn from practice placements during investigation of the concerns.
- 40.10 Students who experience health issues that render them unable to practise safely and effectively may be unable to achieve the accredited award of BSc (Hons) Speech and Language Therapy.
- 40.11 Students must complete a course of immunisation as advised by Occupational Health. Occupational Health will provide further advice on being vaccinated, and what vaccines may be required. Without Occupational Health clearance and immunisation cover, students will not be able to attend clinical placements. Failure to undertake a course of immunisation as advised by Occupational Health may result in removal from the programme.

Awards of the university

- 40.12 Students may exit from the programme at the end of Level 4 with the appropriate award under generic regulations. Such an award is not an approved professional qualification. The title of this award will be Certificate of Higher Education in Human Communication.
- 40.13 Students may exit from the programme at the end of Level 5 with the appropriate award under generic regulations. Such an award is not an approved professional qualification. The title of this award will be Diploma of Higher Education in Human Communication.
- 40.14 Students may exit from the programme at the end of Level 6 with a non-honours degree under generic regulations but without the professional qualification and eligibility to apply to the Health and Care Professions Council for state registration or to the Royal

College of Speech and Language Therapists for a Certificate of Membership. The title of this degree will be BSc Human Communication.

- 40.15 Students who are awarded an aegrotat degree under general regulations will not be eligible to apply to the Health and Care Professions Council for state registration or to the Royal College of Speech and Language Therapists for a Certificate of Membership.

Maximum period of registration

- 40.16 The normal expected duration of the programme is three years full time study. The maximum period of registration for the programme is normally five years and the maximum period allowed for studying at any one level is normally two years.

Other requirements

- 40.17 Continuation on the programme is subject to enhanced DBS clearance and annual completion of a self-declaration. DBS application and self-declaration must be completed by the end of teaching week one after registration and re-registration respectively. Failure to complete a DBS and annual self-declaration will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.
- 40.18 In line with professional body requirements, at least one External Examiner appointed to the programme will be registered with the Health and Care Professions Council as a speech and language therapist.

41. Speech and Language Therapy BSc (Hons), B60051 (for students registered before September 2024)

Allied Health Sciences, Health and Care Professions Council (HCPC), The Royal College of Speech and Language Therapists

Passing a module/compensation

- 41.1 All modules are must-pass modules and students must achieve a minimum pass mark of 40 per cent. No compensation is available.

Reassessment of failure

- 41.2 A student will have a maximum of 90 credits of reassessment opportunities at each level of study.

Failure in clinical practice

- 41.3 Students who fail SALT2201 (professional practice 2) may have only two reassessment opportunities for that module. Students exceeding this will only be eligible to continue on a route for an academic award without eligibility for state registration.

- 41.4 Students who fail SALT3202 (professional practice 3) due to failure in the clinical placement report completed by their clinical educator (but not the coursework assignment and clinical viva) may have only one reassessment opportunity. Students who fail SALT3202 due to failure in the coursework assignment and clinical viva may have only two reassessment opportunities. Students exceeding this will only be eligible for an academic award without eligibility for state registration.

Proceeding between undergraduate levels of study for full-time students

- 41.5 Students may normally only proceed into year two on successful completion of all Level 4 modules except students may proceed carrying one failed component of SALT1008, Introduction to phonetics and phonology, (practical phonetics component, threshold 66%), providing this is retrieved by the end of the second year.

- 41.6 Students may normally only proceed into year three on successful completion of all Level 5 modules except students may proceed carrying one failed component of SALT2202, clinical linguistic assessments (practical phonetics component, threshold 66%), providing that this is retrieved by the end of the third year.

Proceeding between undergraduate levels of study for part-time students

- 41.7 Students studying part-time must normally successfully complete all modules in each year of study before proceeding to the next except students may proceed carrying one failed component of SALT1008, introduction to phonetics and phonology (as paragraph one above), and SALT2202, clinical linguistic assessments (as paragraph two above), provided the failed component is retrieved in the next year of study.

Fitness to practise

- 41.8 In order to attend practice placements and to be eligible to apply for professional registration students must be in sufficiently good mental and physical health to be able to practise without risk to themselves or others. Students must notify the Clinical Placement Lead if they experience changes to their health status which might have an impact upon fitness to practise. Students about whom there are serious concerns over professional conduct or fitness to practise may be withdrawn from practice placements during investigation of the concerns.
- 41.9 Students must attend for occupational health assessment if asked to do so by the programme leader or deputy. Students who experience such health issues as render them unable to practise safely and effectively may, at the discretion of the assessment board, be unable to pursue the professional programme.
- 41.10 Students must complete a course of immunisation as advised by Occupational Health. Occupational Health will provide further advice on being vaccinated, and what vaccines may be required. Without Occupational Health clearance and immunisation cover,

students will not be able to attend clinical placements. Failure to undertake a course of immunisation as advised by Occupational Health may result in removal from the programme.

Awards of the university

- 41.11 In exceptional circumstances it is possible for students to transfer to a non-clinical route. In this case students will be awarded an honours or non-honours degree but without the professional qualification or eligibility to apply to the HCPC for state registration or to the Royal College of Speech and Language Therapists for a Certificate of Membership. The title of this degree will be BSc Human Communication. Awards and proceeding on a non-clinical route will be subject to generic regulations.

Other requirements

- 41.12 Continuation on the programme is subject to enhanced DBS clearance and annual completion of a self-declaration. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration and re-registration respectively.
- 41.13 Failure to complete a DBS and annual self-declaration will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

Postgraduate Programmes

42. MSc Advanced Clinical Practice, B90081

Nursing & Midwifery

- 42.1 The programme incorporates a non-medical prescribing course, allowing students register as a prescriber with their relevant regulatory body. This course has different assessment criteria from the University's regulations; these are set by the Nursing and Midwifery Council (NMC), the Health and Care Professions Council (HCPC), and the General Pharmaceutical Council (GPhC). NMC and HCPC accreditation applies to PRES5005 and PRES5006. GPhC accreditation applies to PHAR5879.
- PRES5005 (Applied Prescribing) and PRES5006 (Pharmacology for Prescribers) must be studied concurrently and both must be passed.
 - Students undertaking PRES5005 Applied Prescribing will have one resit opportunity for each assessment component (the assignment and the portfolio).

- Students undertaking PRES5006 Pharmacology for Prescribers will have one resit opportunity for both the pharmacology exam and the assignment.
- Students undertaking PRES5006 Pharmacology for Prescribers will have one resit opportunity for the numeracy exam within the module. If the student fails both the first and resit attempt, they will be allowed one final resit opportunity after the assessment board.
- The pass mark for the pharmacology exam in PRES5006 Pharmacology for Prescribers is 80%.
- The pass mark for the numeracy exam in PRES5006 Pharmacology for Prescribers is 100%.

42.2 On all other modules except those listed above, students who commenced their studies before October 2023 can be reassessed once in each module, and students who commenced their studies from October 2023 onwards can be reassessed twice.

Recognition of Prior Learning (RPL)

42.3 Where an applicant already holds the V300 prescribing qualification, the University will recognise this through the Recognition of Prior Learning (RPL) process against Level 7 credits.

42.4 If the applicant has achieved the V300 prescribing qualification at Level 6, the University will recognise this through the RPL process. The applicant can bring in a maximum of 30 academic credits at Level 6 to be recognised against the Level 7 prescribing modules on the programme. The prescribing modules at DMU are 45 credits. Therefore, to achieve a further 15 credits, the applicant will undertake the MPHE5204 Independent Study module (15 credits).

42.5 If the applicant has achieved the V300 prescribing qualification at Level 7, the University will recognise this through the RPL process. The applicant can bring in a maximum of 90 academic credits at Level 7. V300 prescribing qualifications at other institutions can be between 30 – 60 academic credits. The prescribing modules at DMU are 45 credits. Therefore, if the applicant's V300 prescribing qualification is worth less than 45 credits, they will undertake the MPHE5204 Independent Study module (15 credits).

43. MSc Advanced Clinical Practice, B90082 (Apprenticeship)

Nursing & Midwifery

- 43.1 The programme incorporates a non-medical prescribing course, allowing students register as a prescriber with their relevant regulatory body. MPHE5807 End Point Assessment (EPA)

- 43.2 Students are only allowed one resit opportunity for either or both of the End Point Assessment (EPA) components. A re-sit opportunity should be offered following formal confirmation of the failed assessment component(s) by the EPAO. The employer must also confirm to the EPAO that they support the apprentice in retaking the EPA. Any EPA component must be taken within three months of formal confirmation of the failed EPA. A resit of either component will limit the overall EPA grade to a pass, except where an application for extenuating circumstances has been upheld by the EPAO. Apprentices are only required to resit the failed component of the EPA. Students may only resit the EPA if they have failed the first attempt; resits cannot be used to improve a pass/merit result.

- Students undertaking PRES5006 Pharmacology for Prescribing in ACP will have one resit opportunity for the numeracy exam within the module. If the student fails both the first and resit attempt, they will be allowed one final resit opportunity after the assessment board.
- The pass mark for the pharmacology exam in ACPD5006 Pharmacology for Prescribing in ACP is 80%.
- The pass mark for the numeracy exam in ACPD5006 Pharmacology for Prescribing in ACP is 100%.

ACPD5008 End Point Assessment (EPA)

44.2 Students are only allowed one resit opportunity for either or both of the End Point Assessment (EPA) components. A re-sit opportunity should be offered following formal confirmation of the failed assessment component(s) by the EPAO. The employer must also confirm to the EPAO that they support the apprentice in retaking the EPA. Any EPA component must be taken within three months of formal confirmation of the failed EPA. A resit of either component will limit the overall EPA grade to a pass, except where an application for extenuating circumstances has been upheld by the EPAO. Apprentices are only required to resit the failed component of the EPA. Students may only resit the EPA if they have failed the first attempt; resits cannot be used to improve a pass/merit result.

44.3 On all other modules except those listed above, students can be reassessed once in each module.

PHAR5879 Practice Certificate in Independent Prescribing

44.4 This module has different assessment criteria from the University's regulations; these are set by the General Pharmaceutical Council (GPhC). Resubmissions are allowed for failed components only. Students who fail to achieve the required standard for any assessment component of this module will be given advice and asked to resubmit the component(s) on one further occasion. The higher mark a student can achieve for a resubmitted component is 50%. In such circumstances, the overall module mark will be capped at 50%. Failure on resubmission will normally result in dismissal from the programme. For the OSCE examination, only those stations that originally failed will need to be resat.

Reassessment of failure

- 44.5 Clinical Portfolio One (MPHE5813), Two (MPHE5814), and Three (MPHE5815) for Advanced Practitioners may be reassessed once only.

Recognition of Prior Learning (RPL)

- 44.6 Where an applicant already holds the V300 prescribing qualification, the University will recognise this through the Recognition of Prior Learning (RPL) process against Level 7 credits.
- 44.7 If the applicant has achieved the V300 prescribing qualification at Level 6, the University will recognise this through the RPL process. The applicant can bring in a maximum of 30 academic credits at Level 6 to be recognised against the Level 7 prescribing modules on the programme. The prescribing modules at DMU are 45-credit modules. Therefore, to achieve a further 15 credits, the applicant will undertake one of the following 15-credit modules: MPHE5204 (Developing Health and Professional Practice, PCPH5053 (Professional Healthcare Advocacy), PCPH5057 (Professional Midwifery Advocacy), or PCPH5052 (Professional Nurse Advocacy).
- 44.8 If the applicant has achieved the V300 prescribing qualification at Level 7, the University will recognise this through the RPL process. The applicant can bring in a maximum of 90 academic credits at Level 7. V300 prescribing qualifications at other institutions can be between 30 – 60 academic credits. The prescribing modules at DMU are 45-credits modules. Therefore, if the applicant's V300 prescribing qualification is worth less than 45 credits, to achieve a further 15 credits, the applicant will undertake one of the following 15-credit modules: MPHE5204 (Developing Health and Professional Practice, PCPH5053 (Professional Healthcare Advocacy), PCPH5057 (Professional Midwifery Advocacy), or PCPH5052 (Professional Nurse Advocacy).

End Point Assessment (EPA) Exam Results

- 44.9 The release of marks for the Advanced Clinical Practice EPA exam is extended to 20 days to allow for external (independent assessor) and internal (internal moderator) marking processes. All usual processes will continue but with an extended time frame for completion.

45. MSc Advanced Clinical Practice, B90085

Nursing & Midwifery

- 45.1 The programme incorporates a non-medical prescribing course, allowing students register as a prescriber with their relevant regulatory body. This course has different assessment criteria from the University's regulations; these are set by the Nursing and

Midwifery Council (NMC), the Health and Care Professions Council (HCPC), and the General Pharmaceutical Council (GPhC). NMC and HCPC accreditation applies to PRES5005 and PRES5006. GPhC accreditation applies to PHAR5879.

- PRES5005 (Applied Prescribing) and PRES5006 (Pharmacology for Prescribers) must be studied concurrently and both must be passed.
- Students undertaking PRES5005 (Applied Prescribing) will have one resit opportunity for each assessment component (the assignment and the portfolio).
- Students undertaking PRES5006 (Pharmacology for Prescribers) will have one resit opportunity for both the pharmacology exam and the assignment.
- Students undertaking PRES5006 (Pharmacology for Prescribers) will have one resit opportunity for the numeracy exam within the module. If the student fails both the first and resit attempt, they will be allowed one final resit opportunity after the assessment board.
- The pass mark for the pharmacology exam in PRES5006 (Pharmacology for Prescribers) is 80%.
- The pass mark for the numeracy exam in PRES5006 (Pharmacology for Prescribers) is 100%

45.2 On all other modules except those listed above, students who commenced their studies before October 2023 can be reassessed once in each module, and students who commenced their studies from October 2023 onwards can be reassessed twice.

PHAR5879 Practice Certificate in Independent Prescribing

45.3 This module has different assessment criteria from the University's regulations; these are set by the General Pharmaceutical Council (GPhC). Resubmissions are allowed for failed components only. Students who fail to achieve the required standard for any assessment component of this module will be given advice and asked to resubmit the component(s) on one further occasion. The higher mark a student can achieve for a resubmitted component is 50%. In such circumstances, the overall module mark will be capped at 50%. Failure on resubmission will normally result in dismissal from the programme. For the OSCE examination, only those stations that originally failed will need to be resat.

Reassessment of failure

45.4 Clinical Portfolio One (MPHE5813), Two (MPHE5814), and Three (MPHE5815) for Advanced Practitioners may be reassessed once only.

Recognition of Prior Learning (RPL)

- 45.5 Where an applicant already holds the V300 prescribing qualification, the University will recognise this through the Recognition of Prior Learning (RPL) process against Level 7 credits.
- 45.6 If the applicant has achieved the V300 prescribing qualification at Level 6, the University will recognise this through the RPL process. The applicant can bring in a maximum of 30 academic credits at Level 6 to be recognised against the Level 7 prescribing modules on the programme. The prescribing modules at DMU are 45 credits. Therefore, to achieve a further 15 credits, the applicant will undertake the MPHE5204 Independent Study module (15 credits).
- 45.7 If the applicant has achieved the V300 prescribing qualification at Level 7, the University will recognise this through the RPL process. The applicant can bring in a maximum of 90 academic credits at Level 7. V300 prescribing qualifications at other institutions can be between 30 – 60 academic credits. The prescribing modules at DMU are 45 credits. Therefore, if the applicant's V300 prescribing qualification is worth less than 45 credits, they will undertake the MPHE5204 Independent Study module (15 credits).

46. Applied Health Studies MRes, B90075

Applied Social Sciences, No PSRB applicable

Introduction to modules

- 46.1 The dissertation is 45 rather than 60 credits.

47. Clinical Pharmacy/ Clinical Pharmacy (with Independent Prescribing) MSc/PGDip/PGCert, B23077 and B23087

Pharmacy, General Pharmaceutical Council (GPhC) for Independent Prescribing only

Recognition of Prior Learning (RPL)

- 47.1 For MSc only, the programme allows RPL of up to 120 credits for applicants with a postgraduate diploma and who had undertaken a relevant research methods module as part of their previous programme.
- 47.2 All other RPL requests will be operated at programme rather than module level, with other existing principles of RPL applying and with RPL requests accepted in multiples of 15 credits, rounded down to the nearest 15 credits where applicable.

Maximum period of registration

- 47.3 The maximum period of registration for the Diploma is five years, including a maximum period of three years for the certificate stage.

Module assessment

- 47.4 Students must pass the Concepts in Research module (PHAR5880) in order to complete the Dissertation module (PHAR5881).
- 47.5 For the Independent Prescribing Module(s) (PHAR5557, PHAR5558 or PHAR5879) any error or action in a summative assessment which may potentially cause patient harm will be reviewed in light of current clinical practice descriptors of harm stratification. This review will take place by a panel which will consist of a minimum of the marker, the internal moderator, the module leader and the external examiner, plus a currently practising non-medical prescriber.
- 47.6 Any incident or omission that causes the death, or would have the potential (for example in theoretical work) to cause the death, of one or more persons, will result in failure of the whole course, with no re-assessment opportunity.
- 47.7 Any incident or omission that would cause permanent or long-term harm, or would have the potential (for example in theoretical work) to cause permanent or long-term harm, to one or more persons will result in an overall failure of the Independent Prescribing module and will require resubmission of all of the assessments, not just the one failed. All original submissions will be given a mark of 0%. The student will be required to provide additional reflection to demonstrate learning from the event.
- 47.8 Any incident that would result in, or would have the potential (for example in theoretical work) to result in, further treatment, possible surgical intervention, cancelling of treatment, or transfer to another area, will result in failure of the relevant assessment with a mark of 0%. Only the failed assessment must be re-submitted. The student will be required to provide additional reflection to demonstrate learning from the event.
- 47.9 Any incident that required, or would have the potential (for example in theoretical work) to require extra observation or minor treatment and caused minimal harm to one or more persons, will result in appropriate advice, but not a failure of the assessment. The student may be requested to provide additional reflection to demonstrate learning from the event.

48. Community and Criminal Justice Leadership MA, L54171

Applied Social Sciences, No PSRB applicable

Introduction to modules

- 48.1 The dissertation is 45 rather than 60 credits.

Passing a module

- 48.2 All essential module components must be passed at 50%.

49. District Nursing PG Dip, B70273 and B70274 (Apprenticeship) with V300 Prescribing

Nursing & Midwifery, Nursing and Midwifery Council (NMC)

Recognition of Prior Learning (RPL)

- 49.1 Where an applicant already holds the V300 prescribing qualification, the University will recognise this through the Recognition of Prior Learning (RPL) process.
- 49.2 V300 prescribing qualifications at other institutions can be between 30 and 60 academic credits.
- 49.3 If the applicant has achieved the V300 prescribing qualification at Level 6, the University will recognise this through the RPL process. The applicant can bring in 30 academic credits at Level 6 to be recognised against the Level 7 prescribing modules on the programme. The prescribing modules at DMU are 45 credits. Therefore, to achieve a further 15 credits, the applicant will undertake the MPHE5204 Independent Study module (15 credits).
- 49.4 If the applicant has achieved the V300 prescribing qualification at Level 7, the University will recognise this through the RPL process. The prescribing modules at DMU are 45 credits. Therefore, if the applicant's prescribing qualification is only worth 30 credits, they will undertake the MPHE5204 Independent Study module (15 credits).

Passing a module/compensation

- 49.5 All module components must be passed at 50%. All zero-credit (pass/fail) components must be passed.

Other requirements

- 49.6 Independent and Supplementary Prescribing (V300) modules PRES5005 and PRES5006 must be passed.

- 49.7 PRES5005 (Applied Prescribing) – students will have one reassessment opportunity for each assessment component (the assignment and the portfolio).
- 49.8 PRES5006 (Pharmacology for Prescribers) – students will have one reassessment opportunity for both the pharmacology exam and the assignment. Students will have two reassessment opportunities for the numeracy exam.
- 49.9 The pass mark for the pharmacology exam in PRES5006 Pharmacology for Prescribers is 80%.
- 49.10 The pass mark for the assignment in PRES5006 Pharmacology for Prescribers is 50%.
- 49.11 The pass mark for the numeracy exam in PRES5006 Pharmacology for Prescribers is 100%.

50. Empowering Education PGCert, X30084

Applied Social Sciences, No PSRB applicable

Maximum period of registration

- 50.1 The maximum period of registration for students registered part time on the Postgraduate Certificate in Empowering Education is four years.

51. Low Intensity Psychological Interventions PGCert, C84080

Applied Social Sciences, British Psychological Society (BPS)

Introduction to modules

- 51.1 The programme consists of 20-credit modules.

Passing a module

- 51.2 All module components must be passed at 50%. All zero-credit (pass/fail) components must be passed.

Reassessment of failure

- 51.3 Students are only allowed one reassessment opportunity per module.
- 51.4 Failure of a module due to gross professional misconduct will result in immediate dismissal from the programme.
- 51.5 Students must maintain contractual services with the designated service provider for the duration of the programme. If they fail to do so they will be suspended pending investigation and may be dismissed from the programme.

Attendance

- 51.6 Each module has a 100% attendance requirement for taught content. The clinical practice element has an 80% attendance requirement. If a student falls below these requirements they must demonstrate that they have completed any missed work.

Awards of the university

- 51.7 Classification is based on the overall average mark or, if students have 40 credits in the higher banding, the higher classification award will be applied.

52. Physician Associate Studies MSc, B96071

Allied Health Sciences, No PSRB applicable

Proceeding to second year of the programme

- 52.1 In order to proceed to the second-year clinical placements, students must pass 90 credits, carrying forward the remaining 30 credits as a resit or deferral. These 90 passed credits must include PHAS5003. Only one reassessment attempt is allowed per module.

Eligibility to start the postgraduate dissertation, major project and design work

- 52.2 In order to become eligible to start the practice-related project (PHAS5006), students must have passed at least 90 credits from the first year (including PHAS5003 and carrying forward no more than 30 credits in resit/deferrals and no fails in resits).

Passing a module

- 52.3 For PHAS5003 Examination 2 OSCE, all OSCE stations are weighted according to difficulty. Students must achieve a mark of 50% or above (calculated through techniques including linear regression). In addition, 66% of all stations must be passed.
- 52.4 For PHAS5007 Practical OSCE, all OSCE stations are weighted according to difficulty. Students must achieve a mark of 50% or above (calculated through techniques including linear regression). In addition, 66% of all stations must be passed.
- 52.5 For PHAS5007, both components are a pass/fail, however both the clinical portfolio and final OSCE must achieve a pass, in order to achieve a MSc or PG Dip in Physician Associate Studies award.

Awards of the university

- 52.6 The award of the MSc in Physician Associate Studies will be awarded only if all components have been passed.
- 52.7 A MSc in Clinical Sciences will be awarded if 180 credits have been passed, (but the student has not passed the clinical portfolio).

- 52.8 A PG Dip in Physician Associate Studies will be awarded if the following have been passed: 120 credits (not including the practice-related project) plus the clinical portfolio.
- 52.9 A PG Dip in Clinical Sciences will be awarded if 120 credits have been passed, but the student has failed the clinical portfolio.
- 52.10 A PG Cert in Clinical Sciences will be awarded if 60 credits have been passed from the first year of study.
- Maximum period of registration**
- 52.11 Maximum registration period (MRP) for the Physician Associate MSc programme is 4 years
- Other requirements**
- 52.12 Continuation on the programme is subject to enhanced DBS clearance and annual completion of a self-declaration. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration and re-registration respectively.
- 52.13 Failure to complete a DBS and annual self-declaration will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

53. Practice Nursing PG Cert, B70099

Nursing & Midwifery, Nursing and Midwifery Council (NMC)

Introduction to programmes and modules

- 53.1 The programme consists of one 60-credit module.

Passing a module/compensation

- 53.2 All module components must be passed at 50%. All zero-weighted (pass/fail) components must be passed.

Reassessment of failure

- 53.3 A maximum of 60 credits of reassessment are permitted. Each module component may only be reassessed once.

54. Professional Clinical Practice MSc/PG Dip/PG Cert, B70272

Nursing & Midwifery, Nursing and Midwifery Council (NMC) accreditation applies to PRES5005 and PRES5006

Passing a module

- 54.1 Students undertaking PRES5005 Applied Prescribing Module will have one reassessment opportunity for each assessment component (the Reflection and the Portfolio).
- 54.2 Students undertaking PRES5006 Pharmacology for Prescribers will have one reassessment opportunity for both the pharmacology exam and the assignment.
- 54.3 Students undertaking PRES5006 Pharmacology for Prescribers will have one reassessment opportunity for the numeracy within the module. If the student fails both these attempts, they will be allowed one final reassessment opportunity after the exam board.
- 54.4 The pass mark for the pharmacology exam in PRES5006 Pharmacology for Prescribers is 80%.
- 54.5 The pass mark for the numeracy exam in PRES5006 Pharmacology for Prescribers is 100%.
- 54.6 PRES5005 and PRES5006 must be taken together and must both be passed.

55. Psychology Conversion MSc, C80071

Applied Social Sciences, British Psychological Society (BPS)

Recognition of Prior Learning (RPL)

- 55.1 RPL is limited to a maximum of 60 Level 7 credits. BPS requirements stipulate that RPL cannot include experiential (or informal) learning. RPL cannot be applied against the Psychology Dissertation module (PSYC5106).

56. Social Work MA, L50080

Applied Social Sciences, Social Work England (SWE)

Introduction to modules

- 56.1 The dissertation is 45 rather than 60 credits.

Reassessment of failure

- 56.2 Students must satisfy the attendance requirement of 70% for all academic modules.
- 56.3 Students must achieve 100% attendance for the required placement days in SCWK5007 and SCWK5008.
- 56.4 Students must satisfy the 100% attendance requirement for SCWK5010 and SCWK5011.
- 56.5 Where attendance is between 70-99% students are able to provide retrieval summaries for missed workshops.
- 56.6 Students will have to re-attend the module the following academic year if they have less than 70% attendance, unless they are in the consideration band (65-69%) and an attendance pass is agreed based on evidence submitted.
- 56.7 For SCWK5007 (Placement 1) and SCWK5008 (Placement 2) students will only be allowed 2 attempts at both the practice and portfolio elements of the module.

Proceeding to second year of the programme

- 56.8 No student can start their first placement in year 2 without having passed all academic parts of all year 1 modules.
- 56.9 Students must pass SCWK5007 – Placement 1 (practice and portfolio elements) before they are able to proceed to SCWK5008 – Placement 2.
- 56.10 Students are able to proceed to SCWK5008 (Placement 2) carrying a fail for the SCWK5009 (Dissertation) module and outstanding SCWK5011 (Skills Development) absence retrievals.

Postgraduate awards

- 56.11 A student must complete 180 academic credits and the zero-credit Placement modules to receive the MA Social Work and qualify for registration with Social Work England.
- 56.12 If a student achieves all year 1 modules (135 academic credits) and all Placement modules (SCWK5007 and SCWK5008) and Skills Development modules SCWK5010 and SCWK5011, but fails the Dissertation module (SCWK5009), they will be able to exit the programme with a PG Diploma in Social Work and qualify for registration with Social Work England.

Other requirements

- 56.13 Continuation on the programme is subject to enhanced DBS clearance and annual completion of a self-declaration. The DBS application and self-declaration must be completed by the end of teaching week 4 after registration and re-registration respectively.

- 56.14 Failure to complete a DBS and annual self-declaration will result in a review of continued registration; typically, the outcome of which will be discontinuation from the programme.

57. Social Work Practice Education PGCert, L50078

Applied Social Sciences, Social Work England (SWE)

Awards of the University

- 57.1 SCWK5101 – practice educator stage one: students must pass the practice mentor assessor report before they are eligible to start SCWK5102 – practice educator stage two.
- 57.2 This is to ensure that students have demonstrated Social Work England requirements for stage one practice educator professional standards before proceeding to stage two.
