The teaching includes preparation and delivery of lectures and seminars, teaching of research methods, setting and marking of assessments, and project supervision.

We would particularly welcome applications from candidates with expertise in clinical psychology. • To contribute to the delivery of psychology and research methods at undergraduate and postgraduate level. • To supervise and assess research projects at undergraduate level, including final year projects. • To set and mark assignments and examinations. • To be student-centred with a commitment to providing a first-class student experience. • To work to the quality assurance systems of the University, School and Division. • To attend Divisional meetings, and to represent the Division at other meetings as required. • To have an administrative role commensurate with the post. • To help develop and contribute to the strategic direction of psychology including the area of employability. • Perform any other duties commensurate with the job grade as reasonably required from time to time. • Treat all DMU staff, students, contractors and visitors with dignity and respect.
